Ordinance No. 103

An Ordinance Making and Levying Special Assessments and Interest on the Lots and Parcels of Ground hereinafter Described and Liable for the Costs of Grading, Curbing Guttering and Paving, Except Squares and Areas formed by Intersections of Streets and Alleys of Doniphan Street between Freemont and Benton streets, of Jesse Street between Greal and Moss Streets, of Benton Street, between Jesse and Benton Streets, of Creal Street between Court and St. Joseph Streets, of Court Street between Court Street and St. Joseph Street: All in the City of Wathena, Kansas.

Be it ordained by the Mayor and Councilmen of the City of Wathena, Kansas,

Sec. 1. That for the purpose of paying the cost and expenses of Grading, Curbing, Guttering and Paving that part of Doniphan Street between Fremont and Benton Streets, that part of Jesse Street between Creal and Moss Streets, that part of Bryant Street between Jesse and Benton Streets, that part of Court Street between Doniphan Street and the end of the paving west of Stewart Street, and that part of Stewart Street between Court and St. Joseph Street except in squares and areas formed by the crossing of streets and alleys, and said grading being that made necessary after the said streets are brought to grade: the following Lots and parcels of ground respectively, as the proportion or the cost and expenses of said grading, guttering, and paving, including on half the engineering expenses, to be paid by the owners of said lots or parcels of ground, to-wit:

Sec. 2. Said levy and assessments shall be due and payable, as are other taxes, in ten installments, first installment being due in 1925 and the remaining installments due and payable of one-tenth of each assessment in each and every thereafter til said assessments are fully paid. That if said installments are not paid when due and payable, there shall be added a further charge on the respective lots and parcels of ground the same penalties and interest as are levied for delinquent taxes. That the owner of any lot or parcel of ground liable for such assessment may at any time within thirty days after the publication of this notice or ordinance, pay the said assessment in full on any said lot or parcel of ground to the City Treasurer of said city and the said lots and parcels of ground so paid on shall not thereafter be liable for any further assessments or interest in the cost of said improvement.

Sec. 3. That there is hereby levied and assessed against each lot and parcel of ground described in Section One hereof, five parcent per annum on said installments, save those which may be paid in full within said thirty days, said interest to run from date of the improvement bonds hereafter to be issued to-wit: The Fifteenth day of July 1925, and until the payment of each installment as provided herein. The City Clerk as provided by law shall certify to the County Clerk of Doniphan County, Kansas, a list of said lots and parcels of ground liable for said assessments with the installments figured for each year and on which assessment have not been paid, together with interest and any unpaid installment, and such amount so certified shall be collected as are other taxes and applied as provided by law towards the payment of said improvement bonds and the repayment of such assessments or installments as have not been paid by said city.

Sec. 4. This ordinance shall take effect and be in full force from and after its publication once in the official city paper.
