

Ordinance No. 106

An Ordinance Authorizing and Providing for the Issuance of Water Works Bonds of the City of Wathena, Kansas.

Whereas, By an ordinance duly passed by the Mayor and Councilmen of the City of Wathena, Doniphan County, Kansas, as an election of the inhabitants of said city was held on the 1st day of September, 1925 for the purpose of voting on the issuance of the bonds of said City for the purpose of constructing water works for the purpose of supplying the inhabitants of said city with water at which election the majority of the electors voting were in favor of the issuance of said bonds in the sum of \$41,000.00.

Whereas, In accordance therewith, the said Mayor and Councilmen have entered into contracts for the construction of said water works for the contract price of \$41,000.00.

Now therefore be it ordained by the Mayor and Councilmen of the City of Wathena, Doniphan County, Kansas.

Sec. 1. That the cost of constructing Water Works in the City of Wathena, Doniphan County, Kansas, in accordance with the vote of the electors of said city, shall be paid from the proceeds of the internal improvements bonds of said city in the sum of \$41,000.00 which bonds shall be issued and dated the 15th day of September, 1925, shall bear 4 3/4 percent interest per annum payable semiannually on the fifteenth day of January and July of each year at the Fiscal Agency of the State of Kansas, in the city of Topeka, Kansas, and evidenced by interest coupons attached to said bonds, the first interest coupons becoming due on Said bonds shall be numbered, be in amount and mature as follows.

And it is further declared and certified that all acts, conditions and things required to be done and to exist precedent to the issuing of this notice have been properly done and performed and do exist in due and regular form as required by the Constitution and Laws of the State of Kansas, and that the total bonded indebtedness of said city of Wathena, including this issue of bonds does not exceed any constitutional or statutory limitation.
