An Ordinance Authorizing the Issuance of Internal Improvement Bonds of The City of Wathena, oniphan County, Kansas, in the sum of \$39,347.00 for the Purpose of Paying the Cost of constructing a sewer system for said city.

Whereas, in pursuance of proceedings duly had and taken by the Mayor and Councilmen of the City of Wathena, Doniphan County, Kansas, a contract has heretofore been let for the construction of a sewer system in and near and for the benefit of said city: all in accordance with Ordinances of said city and numbered 108 and 109, and duly and legally passed and approved by the Mayor and Councilmen of said city, and

Whereas, Said sewer system has been constructed in accordance with the plans and specifications of the City Engineers duly approved by the Mayor and Councilmen of said city and the total cost of said improvement has been and is hereby ascertained to be in the sum of \$39,347.00 and that all of said cost has been and is hereby charged against the property, realand personal, in said city, and

hereas, all legal requirements have been duly complied with to authorize the issuance of the bonds of said city for the payment of the said sum of \$39,347.00 and it has been and is hereby determined necessary to issue bonds of said city in said sum to secure funds with which to pay the cost of said improvement.

Now therefore, be it ordained by the Mayor and Councilmen of the City of Wathena, Doniphan County, Kansas, as follows:

Sec. 1. That for the purpose of providing funds with which to pay the cost of constructing s sewer system for the City of Wathena, Doniphan County, Kansas, the boundaries of said sewer system being the entire City of Wathena as provided for in Ordinance No. 108, published on the sixth day of May, 1926, there shall be issued and hereby are issued a series of Internal Improvement Bonds of said City of Wathena, Doniphan County, Kansas, aggreating the principal sum of \$39,347.00. Said series shall consist of 40 bonds numbered from 1 to 40 inclusive, one of said bonds being in the sum of \$39,347.00 and 39 of said bonds shall be in the sum of \$1,000.00 each. All of said bonds shall be dated the 28th day of May, 1926 and shall become due as follows:
