Ordinance No. 117.

An Ordinance of the City of Wathena, kansas, Authorizing the Issuance of funding bonds of said city, in the sum of \$19,620. for the Purpose of paying indebtedness existing on the 17th day of march, 1927, under the provision of Chapter 94, session laws of Kansas, 1927.

Whereas, On and before the 17th day of March 1927, the city of Wathena, Doniphan County, Kansas, was in debt in the sum of \$19,620.00 as evidenced by three warrants of said city, one numbered 371 and amounting on said date to the sum of \$9,581.92; one numbered 83 and amounting on said date to the sum of \$6,039.00 and one numbered 395 and amounting on said date to the sum of \$4,000.00 and

Whereas, By the Act of the Legislature of the State of Kansas, passed on the 17th day of March, 1927, and being Chapter 94 of the Session laws of the State of Kansas for the year 1927, it was provided that such debts could be funded or refunded into a bonded debt, and

Whereas, said City then had and now has no funds with which to pay off said warrants or any part thereof, and by motion made andpassed, the City Council voted to so refund said debt.

Now therefore be it ordained by the Mayor and Councilmen of the City of Wathena, Doniphan County, Kansas.

Sec. 1. That for the purpose of funding the said debt of said city as represented by said three outstanding warrants, there shall be issued and hereby are issued the refunding bonds of said city of Wathena, aggregating the principal sum of \$19,620.00. Said series of bonds shall consist of 40 bonds numbered from 1 to 40 inclusive, one of said bonds being in the sum of \$120.00 and 39 of said bonds being in the sum of \$500.00 each. All said bonds shall be dated the 1st day of August, 1927 and shall become due as follows:
