AN ORDINANCE AUTHORIZED AND DIRECTING THE CALLING OF A SPECIAL ELECTION IN THE CITY OF WATHENA, DONIPHAN COUNTY, KANSAS, FOR THE PURPOSE OF SUBMITTING TO THE QUALIFIED ELECTORS OF SAID CITY A PROPOSITION TO ISSUE AND SELL BONDS OF SAID CITY IN THE AGGREGATE PRINCIPAL AMOUNT OF NOT EXCEEDING THIRTY-FIVE THOUSAND DOLLARS (\$35,000.00), FOR THE PURPOSE OF EXTENDING AND IMPROVING ITS SYSTEM OF WATER WORKS.

WHEREAS, The Governing Body of the City of Wathena, Doniphan County, Kansas deems it necessary and advisable to extend and improve its system of Water Works by the installation of another well and well pump, an auxiliary high lift pump. a line and soda-ash softener plant, and the purchase or lease of property adjacent to the present pumping station for said improvements; and,

WHEREAS, In order to provide funds to pay the cost of the installation of another well and well pump, an auxiliary high lift pump, a line and soda-ash softener plant, and the purchase or lease of property adjacent to the present pumping station for said improvements, it is necessary to issue bonds of the City of Wathena, Doniphan County, Kansas, in an amount not exceeding \$35,000.00;

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WATHENA, DONIPHAN COUNTY, KANSAS:

Section 1. That the Governing Body, or a majority of them, are hereby authorized and directed to call a special election for the purpose of submitting to the qualified electors of the City of Wathena, Doniphan County, Kansas, a proposition to issue and sell bonds of said City in the

agregate principal amount of not wxceeding \$35,000.00, for the purpose of extending and improving its system of Water Works by the installation of another well and well pump, an auxiliary high lift pump, a line and sodeash softener plant, and the purchase or lease of property adjacent to the present pumping station for said improvements.

Section	2. That said election shall be held on the 15th day of	
July,	1947, and the polling places at said election shall be the	
usual places	of holding elections in said City, to-wit: City Hall

Section 3. The ballots to be used at said election shall be in substantially the following form:



"Shall the City of Wathena, Doniphan County, Kansax, issue and sell bonds of said City in the aggregate principal amount of not exceeding Thirty-five Thousand Dollars (\$35,000.00), for the purpose of extending and improving its system of Water Works by the installation of another well and and well pump, an auxiliary high lift pump, a lime and soda-ash softener plant, and the purchase or lease of property adjacent to the present pumping station for said improvements?

To vote in favor of the bonds make a cross X mark in the square after the word "YES"

To vote against the bonds make a cross X mark in the square after the word "NO" $\,$



Section 4. Notice of said election shall be given in the manner provided by law. Such notice shall set forth the time and place of holding the election and the purpose for which the bonds are to be issued, shall

be signed by the Mayor and Council, or a majority of them, and shall be published in a newspaper of general circulation in said City once each week for three consecutive weeks, the first publication to be not less than twenty-one (21) days prior to said election.

Section 5. All qualified electors residing in the City of Wathena,
Doniphan County, Kansas, shall be entitled to vote at said election. The
City Clerk is hereby authorized and directed to prepare and cause to be
printed ballots substantially in the form hereinbefore provided, and also
to procure the necessary tally sheets and poll books for use at said election, and said election shall be held in all respects according to the
rules and regulations provided by law for holding elections in said City.

Section 6. This ordinance shall be in force and effect from and after its adoption, approval and publication in the official paper of said City.
