ORDINANCE NUMBER 173.

AN ORDINANCE MAKING AND LEVYING SPECIAL ASSESSMENT ON ALL THE LOTS AND PARCELS OF GROUND HEREINAFTER DESCRIBED AND LIABLE FOR THE COSTS AND EXPENSES OF GRADING, RE-GRADING, AND IMPROVING BY THE APPLICATION OF BITUMINOUS ARMOUR COATAING AND/OR OIL AND/OR ROCK CERTAIN OF THE STREETS AND ALLEYS OF THE CITY OF WATHENA AS AUTHORIZED BY RESOLUTIONS ADOPTED JUNE 7, 1949, AUGUST 16, 1949 AND SEPTEMBER 6, 1949.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WATHENA, KANSAS:

SECTION ONE: That for the purpose of paying the cost and expenses of grading, re-grading, and improving by the application of bituminous armour coating and/or oil and/or rock certain of the streets and alleys of the city of Wathena as authorized by resolutions adopted June 7, 1949, and September 6, 1949 the following lots and parcels of ground are hereby assessed the amounts opposite said lots and parcels of ground, respectively as the proportion of the costs and expenses of said improvements, to be paid by the owners of said lots or parcels of ground, to-wit:

Section Two: That the owner of any lot or parcel of ground liable for any such assessment may at any time within thirty days after the publication of this ordinance pay the assessment in full on any said lot or parcel on shall not thereafter be liable for any further assessment for the cost of said work. That the City Clerk, as provided by law, shall certify to the Couty Clerk of Doniphan County, Kansas a list of said lots and parcels of ground liable for said assessments and on which the assessments have not been paid in full as provided above, and such amounts so certified shall be collected as are other taxes.

Section Three: This Ordinance shall take effect and be in full force from and after its publication in the Wathena Times.
