

AN ORDINANCE RELATING TO MOTOR VEHICLES AND REGULATING THEIR OPERATION AND PARKING AND PROVIDING A PENALTY FOR THE VIOLATION OF THIS ORDINANCE

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WATHENA, KANSAS:

SECTION ONE: Ordinance number sixty eight (68) and ordinance number ninety five (95) in so fas as such ordinances are in conflict with any of the provisions hereunder are hereby repealed. Ordinance number one hundred thirty fire (135) is hereby repealed.

SECTION TWO: No person shall operate a motor vehicle on the streets or alleys of said City except on the right side of said street or alley except at an intersection of a street or alley with another street.

SECTION THREE: Vehicles parked on St. Joseph Street between Doniphan Street and Moss Street shall be parked at an angle to the curb as indicated by marks and/or signs.

SECTION FOUR: No truck, except a truck classed as a pick up or panal delivery, shall be parked on St. Joseph Street from Doniphan Street to Bryan Street, except that end zones designated as no-parking zones on St. Joseph Street may be used for loading or unloading or unloading mechandise. Vehicles using these zones shall stand parallel with the curb.

SECTION FIVE: Vehicles parked on the north side of St. Joseph Street from Doniphan Street west to bridge shall be parked at an angle to the curb as indicated by marks and/or signs. Vehicles parked on the south side of St. Joseph Street from Doniphan Street west to bridge shall be parked parallel with the curb.

SECTION SIX: Parking a vehicle on the east side of Doniphan Street from Mill Street to Fremont Street shall be prohibited.
Parking a vehicle on the east side of Bryan Street from St. Joseph Street to the first alley north shall be prohibited.
Parking a vehicle on the east side of Bryan Street from St. Joseph Street to the first alley south shall be prohibited.
Parking a vehicle on the west side of Doniphan Street from St. Joseph Street to a point eighty (80) feet north of the intersection of the intersection of Doniphan Street and St. Joseph Street shall be prohibited.
Parking a vehicle in any alley shall be prohibited.

SECTION SEVEN: The east side of Doniphan Street from St. Joseph Street to a point ninety two (92) feet north of the intersection of Doniphan Street and St. Joesph Street shall be designated as a loading zone and parking in this area shall be prohibited except for loading or unloading passengers or merchandise.

SECTION EIGHT: Vehicles parked on the west side of Bryan Street from St. Joseph Street to the first alley south shall be parked at right angles to the curb. Vehicles parked on the west side of Bryan Street from St. Joseph Street to the first alley north shall park at an angle to the curb and shall enter said parking area from the south. Vehicles traveling south in this area shall not park in said area.

SECTION NINE: Parking a vehicle on a street or alley for more than twenty four (24) hours continuously shall be prohibited.

Parking a vehicle within ten (10) feet of a fire hydrant shall be prohibited. Violation of this section of this ordinance shall be authority for the City Officials to have vehicle towed from street and make charge to owner of vehicle for said tow-in.

SECTION TEN: Any person convicted of violating any of the provisions of this Ordinance shall be fined in a sum not less than \$1.00 and not more than \$25.00.

SECTION ELEVEN: This Ordinance shall be in full force and effect from and after its publication in the Wathena Times on February, 1951.
