ORDINANCE NO. 193

AN ORDINANCE APPORTIONING TO AND LEVYING TAXES AND ASSESSMENTS UPON THE LOTS AND PARCELS OF GROUND IN THE CITY OF WATHENA, KANSAS, AND UPON ALL THE TAXABLE PROPERTY IN THE CITY OF WATHENA, KANSAS, ACCORDING TO THEIR RESPECTIVE LIABILITY THEREFOR, FOR THE COST AND EXPENSE OF CURBING, GUTTERING AND OTHERWISE IMPROVING BOTH SIDES OF BRYAN STREET FROM JESSIE STREET TO THE FIRST ALLEY SOUTH OF COURT STREET; MOSS STREET FROM JESSIE STREET TO ST. JOSEPH STREET; AND NORTH SIDE OF ST. JOSEPH STREET FROM MOSS STREET TO KATY STREET.

WHEREAS, the total cost and expense of curbing, guttering and otherwise improving both sides of Bryan Street from Jessie Street to the first alley South of Court Street; Moss Street from Jessie Street to St. Joseph Street; and North side of St. Joseph Street from Moss Street ot Katy Street has been ascertained to be the sum of \$62,672.51, of which total cost the sum of \$17,410.54 is to be paid by a general tax to be levied upon all the taxable property within the City of Wathena, Doniphan County, Kansas, and the sum of \$45,261.97 to be paid by special assessments to be levied upon the lots and parcels of ground liable therefor; and,

WHEREAS, the appraisement of each lot and parcel of ground liable by law to be assessed for the cost of such improvement has been duly equalized and apportioned at a special meeting duly held for that purpose by the Governing Body of the City of Wathena, Kansas;

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WATHENA, DONIPHAN COUNTY, KANSAS.

Section 1. That for the purpose of paying the cost of curbing, guttering and otherwise improving both sides of Bryan Street from Jessie Street to the first alley South of Court Street; Moss Street from Jessie Street to St. Joseph Street; and North side of St. Joseph Street from Moss Street to Katy Street, the aforesaid sum of \$45,261.97 is hereby assessed and apportioned upon and against the lots and parcels ground liable by law to be assessed for said improvements being made for each block separately and on all lots and parcels of groung to the center of the block on either side of said street along the distance improved according to the assessed value of said lot or parcel of ground, each of which is hereafter described and the sum levied against the same designated as follow, to-wit:

Section 2. That the amount herein before set forth is hereby ascertained, fixed and levied by the Governing Body of the City of Wathena, Kansas, as the amount to be assessed against each lot and parcel of ground to pay for the improvement herein named, which amount may be paid to the City Treasurer within thirty (30) days after the publication of this ordinance, and any of said property upon which said assessment shall be paid shall not be liable for any such sum, or any interest thereon.

Section 3. That the tax or sum herein apportioned to each tract or parcel or ground shall be collected in ten (10) annual instrallments. The first of said installments shall be extended on the tax rolls for the year 1954, and one installment for each year thereafter for the full term of ten (10) years, and that the several sums so assessed and levied shall bear interest at not to exceed the rate of 2-3/4 per cent per annum, and the City Clerk is hereby directed to annually certify and levy the several installments in the proper amounts, with interest, and certify the same to the County Clerk in the manner and within the time provided by law; provided, however, that this section shall not apply to any tract or parcel of ground upon which the full amount of assessment has been paid as provided by Section 2 of this ordinance and authorized by law.

Section 4. This ordinaance shall take effect from and after its passage by the Governing Body and its approval by the Mayor and its publication in the official city paper.
