

ORDINANCE NO. 263

AN ORDINANCE REGULATING TRAFFIC UPON THE STREETS AND HIGHWAYS OF THE CITY OF WATHENA, KANSAS, BY APPROVING AND ADOPTING BY INCORPORATION AND REFERENCE THE STANDARD TRAFFIC ORDINANCE FOR KANSAS CITIES, EDITION OF 1968, AS PREPARED AND PUBLISHED BY THE LEAGUE OF KANSAS MUNICIPALITIES AND BY SEPARATE ENACTMENT AND REPEALING ALL PRIOR TRAFFIC ORDINANCE OF SAID CITY EXCEPT ORDINANCE NO. 228.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WATHENA:

SECTION 1. That pursuant to the provisions of Sections K.S.A. 12-3009 through 12-3012 and K.S.A. 1967 Supp. 12-3301 and 12-3302 the following described standard model code or ordinance, to wit" STANDARD TRAFFIC ORDINANCE FOR KANSAS CITIES, Edition of 1968, as prepared, compiled, published, and promulgated by The League of Kansas Municipalities, 112 West 7th Street, Topeka, Kansas, is hereby adopted and incorporated herein in its entirety by reference and without changes, alternations, additions or deletions, as if the same had been set out in full herein.

SECTION 2. That angle or diagonal parking of motor vehicles, if made in compliance with the remaining terms and provisions of this Ordinance, shall be and is authorized and permitted on the following described streets in said City of Wathena and no others, to wit: On both the North and South sides of St. Joseph Street from its intersection with Moss (2nd) Street to its intersection with Doniphan (4th) Street, on the North side of St. Joseph Street from its intersection with Doniphan (4th) Street West for a distance of sixty (60) feet, on the West side of Bryan (3rd) Street from its intersection with St. Joseph Street North for a distance of one hundred and forty (140) feet, and on the West side of Bryan (3rd) Street from its intersection with St. Joseph Street South for a distance of one hundred and forty (140) feet.

SECTION 3. That pursuant to the requirements of Section K.S.A. 12-3010, four (4) copies of said Standard Traffic Ordinance For Kansas Cities as described and referred to in Section 1 hereof shall be filed with the City Clerk of said City of Wathena and shall be open to inspection and available to the public at all reasonable business hours. Each of said copies shall be marked or stamped

"Official Copy as Incorporated by Ordinance No. 263" and a copy of this Ordinance shall be attached to each of the aforesaid four (4) copies of said document.

SECTION 4. That Ordinance No. 234 of said City of Wathena and all other Ordinances and Sections of Ordinances of said City of Wathena in conflict herewith, except Ordinance No. 228, are hereby repealed.

SECTION 5. That this Ordinance shall take effect and be in force from and after its publication in THE WATHENA TIMES, official City Paper.
