

ORDINANCE NO. 272

AN ORDINANCE ANNEXING CERTAIN LANDS TO THE CITY OF WATHENA, KANSAS, IN CONFORMITY WITH THE PROVISIONS OF KANSAS STATUTES ANNOTATED 1968 SUPPLEMENT 12-520.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WATHENA:

SECTION 1. The following described lands in the County of Doniphan, State of Kansas, to wit:

Beginning at the Southwest corner of the Northwest Quarter of Section 28, Township 3, Range 22, thence North on the East line of said Northwest Quarter and on the existing City Limit line, 725 feet, thence West 1170 feet, thence South 725 feet to the South line of said Northwest Quarter, thence East on the South line of said Northwest Quarter, and on the existing City Limit line, 1170 feet to the point of beginning,

ALSO,

All that part of the South one hundred (100) rods of the Southeast Quarter of Section 21, Township 3, Range 22, which is not presently a part of the City of Wathena, Kansas, or included within the Corporate limits of said City,

ALSO,

All that part of the East twenty (20) rods of the South one hundred (100) rods of the Southwest Quarter of Section 21, Township 3, Range 22, which is not presently a part of the City of Wathena, Kansas, or included within the Corporate limits of said City,

ALSO,

The South fifteen (15) acres of the following described land situate in the Southwest Quarter of Section 21, Township 3, Range 22, to wit: Beginning at a point 660 feet West and 197.8 feet North of the Southeast corner of the Southwest Quarter of Section 21, Township 3, Range 22, thence East 329.6 feet, thence North 1454.4 feet, thence West 1440 feet to the Northeasterly Right-of-Way line of U.S. Highway 36, thence Southeasterly on Said Right-of-Way line to a point which is 1179.5 feet West and 572 feet North of the Southeast corner of said Southwest Quarter, thence East 371.5 feet, thence South 374 feet, thence West 69 feet, thence South 197.8 feet to the South line of said quarter Section, thence East 217 feet on the South line of said Quarter section, thence North to the point of beginning.

meeting one or more of the classifications for annexation prescribed by K.S.A.

1968 Supp. 12-520 are hereby annexed to and made a part of the City of Wathena,

Doniphan County, Kansas, and all of said lands shall hereafter be included within

the corporate limits of said City of Wathena.

SECTION 2. Immediately after this Ordinance shall become effective, the City Clerk of the City of Wathena, Kansas, shall file a certified copy thereof with the County Clerk and with the Register of Deeds of Doniphan County, Kansas.

SECTION 3. This Ordinance shall take effect and be in force from and after its publication in the WATHENA TIMES, Official City Newspaper.
