AN ORDINANCE REGULATING TRAFFIC UPON THE STREETS AND HIGHWAYS OF THE CITY OF WATHENA, KAUSAS, BY APPROVING AND ADOPTING BY HICORPORATION AND REFERENCE THE USTANDARD TRAFFIC ORDINANCE FOR KANSAS CITIES", EDITION OF 1973, AS PREPARED AND PUBLISHED BY THE LEAGUE OF KANSAS MUNICIPALITIES, PROVIDING FOR CERTAIN ADDITIONS TO SAID STANDARD TRAFFIC ORDINANCE FOR KANSAS CITIES, AND REPEALING ORDINANCE NO. 222 OF SAID CITY OF WATHENA.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WATHEWA:

SECTION 1. Pursuant to the provisions of K.S.A. 12-3009 through 12-3012, including any amendments thereto, and K.S.A. 1972 Supp. 12-3301 and 12-3302, the provisions of the Standard Traffic Ordinance for Kansas Cities, Edition of 1973, prepared and published by The League of Kansas Municipalities, and which is contained and available in book or pamphlet form, are hereby adopted and enacted as an ordinance of the City of Mathema, Kansas, and said Standard Traffic Ordinance for Kansas Cities is hereby incorporated and adopted in this ordinance by reference as if the same had been set out in full herein.

SECTION 2. In addition to the provisions contained in the aforesaid Standard Traffic Ordinance for Kansas Cities, it is hereby declared that wherever the terms "Police Chief" or "Chief of Police" as used in said Standard Traffic Ordinance, such terms shall be equivalent and synonymous with the term "City Narshal".

SECTION 3. Further, in addition to the provisions for the parking of vehicles as contained in the aforesaid Standard Traffic Ordinance, it is hereby provided that angle or diagonal parking of motor vehicles, if made in compliance with the remaining terms and provisions of this Ordinance, shall be and is hereby authorized and permitted on the following streets in said City of Wathena and no others, to wit: On both the North and South sides of St. Joseph Street from its intersection with Moss (2nd) Street to its intersection with Doniphan (4th) Street, on the North side of St. Joseph Street from its intersection with Doniphan (4th) Street Vest for a distance of 60 feet, on the Vest side of Bryan (3rd) Street from its intersection with St. Joseph Street North for a distance of 140 feet, and on the Vest side of Bryan (3rd) Street from its intersection with St. Joseph Street South for a distance of 140 feet.

SECTION 4. The City Clerk is hereby directed to mark or stamp upon not less than three copies of the aforesaid Standard Traffic Ordinance for Kansas Cities the following: "Official Copy as incorporated by Ordinance No. " and to attach thereto copies of this incorporating ordinance and thereafter to file the same in his official records to be open to inspection and available to the public at all reasonable business hours.

SECTION 5. Ordinance No. 282 of said City of Wathena and all other ordinances and sections of ordinances of said City which are in conflict herewith are hereby repealed.

SECTION 6. This ordinance shall take effect and be in force from and after its publication in THE WATHEMA TIMES, official City newspaper.
