

ORDINANCE NO. 336

AN ORDINANCE RELATING TO A CERTAIN SUBDIVISION WITHIN THE CITY OF WATHENA, KANSAS, OFFICIALLY NAMING SUCH SUBDIVISION "SUMMIT VIEW", AND ESTABLISHING NAMES FOR THE PUBLIC WAYS WITHIN AND ADJOINING SUCH SUBDIVISION.

WHEREAS, "E" of the Decree of Platting and Dedication duly made and entered by the District Court of Doniphan County, Kansas, on July 20, 1977, in Case No. 10,733 in such Court, wherein The City of Wathena, Kansas, was Plaintiff and John B. Salisbury, et al, were Defendants, provided that an ordinance should be enacted by the Governing Body of the City of Wathena, Kansas, within thirty days from the date of such decree officially naming the subdivision which was ordered platted and dedicated in such decree and also naming the three new public ways which adjoin or are situate within such subdivision:

BE IT THEREFORE ORDAINED BY THE GOVERNING BODY OF THE CITY OF WATHENA:

SECTION 1. NAME OF SUBDIVISION. The subdivision ordered platted and dedicated by Decree of the District Court of Doniphan County, Kansas, as described and referred to in the preamble of this ordinance and in such Decree is hereby officially named and shall hereafter be referred to and called: "SUMMIT VIEW SUBDIVISION".

SECTION 2. NAMES OF PUBLIC WAYS. The public ways within and adjoining the subdivision named and referred to in Section 1 hereof are hereby officially named as follows:

- a. The public way situate and lying between Lots 1, 2 and 3 on the East and Lots 4, 5 and 6 on the West is hereby named "FIRST TERRACE".
- b. The public way situate and lying between Lots 4, 5 and 6 on the East and Lots 7, 8 and 9 on the West is hereby named "SECOND TERRACE".
- c. The public way adjoining Lots 7, 8 and 9 on the West is hereby named "SUMMIT DRIVE",

and such public ways shall hereafter be called and known by the aforesaid names.

SECTION 3. FILING OF ORDINANCE. Immediately after this Ordinance shall become effective, the City Clerk shall file a certified, true and correct copy hereof in the office of the Register of Deeds of Doniphan County, Kansas, for recording in such office as provided in the aforesaid Decree.

SECTION 4. EFFECTIVE DATE. This Ordinance shall take effect and be in force from and after its passage and approval and publication in the official City newspaper.
