## ORDINANCE NO. 340

AN ORDINANCE ESTABLISHING THE SALES PRICE OR RATES FOR WATER SOLD BY THE CITY OF WATHENA, KANSAS, TO CUSTOMERS AND USERS BOTH WITHIN AND WITHOUT THE CORPORATE LIMITS OF SAID CITY AND REPEALING ORDINANCE NO. 325.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WATHENA:

SECTION 1. RATES FOR USERS WITHIN CITY. The following monthly rates and charges are hereby established for water delivered by the City of Wathena to customers located within the corporate limits of such City:

- a. A minimum monthly charge of Five and 75/100 Dollars (\$5.75) per month, which minimum charge shall include and pay for the first 2,000 gallons of water delivered to any one customer in any one month.
- b. For the next 8,000 gallons the sum of One and 20/100 Dollars (\$1.20) for each 1,000 gallons of water, or fraction thereof.
- c. For each 1,000 gallons, or fraction thereof, in excess of 10,000 gallons the sum of 90/100 Dollars  $(90 \not e)$ .

SECTION 2. RATES FOR USERS NOT WITHIN CITY. The following monthly rates and charges are hereby established for water delivered by the City of Wathena to customers located outside the corporate limits of such City:

- a. A minimum monthly charge of Seven and No/100 Dollars (\$7.00) per month, which minimum charge shall include and pay for the first 2,000 gallons of water delivered to any one customer in any one month.
- b. For the next 8,000 gallons the sum of One and 25/100 Dollars (\$1.25) for each 1,000 gallons of water, or fraction thereof.
- c. For each 1,000 gallons, or fraction thereof, in excess of 10,000 gallons the sum of 95/100 Dollars (95%).

SECTION 3. WATER DELIVERED AT STAND PIPE. All water sold by the City in tank lots and delivered at the City stand pipe shall be sold at the rate of Three and No/100 Dollars (\$3.00) per 1,000 gallons sold and delivered with a minimum charge of Twenty-five Cents (25¢) for any single tank lot delivery.

SECTION 4. EFFECTIVE DATE. The rates established by

this Ordinance shall be effective for all water sold and delivered by the City pursuant to all of the foregoing sections from and after June 1, 1978, or from and after the passage of this Ordinance and its publication in the official City paper, whichever date shall be the later.

SECTION 5. REPEALER. Ordinance No. 325 of the City of Wathena is hereby repealed.
