

ORDINANCE NO. 349

AN ORDINANCE AMENDING SECTION 4 OF ORDINANCE NO. 313 OF THE CITY OF WATHENA, KANSAS, RELATING TO SEWAGE SERVICE CHARGES FOR THE USE OF THE SEWAGE DISPOSAL SYSTEM OF THE CITY OF WATHENA, PROVIDING FOR AN AMENDMENT OF SUCH SEWAGE SERVICE CHARGES, AND REPEALING ALL OF ORIGINAL SECTION 4 OF ORDINANCE NO. 313.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WATHENA:

SECTION 1. Section 4 of Ordinance No. 313 of the City of Wathena, Kansas, is hereby amended to read as follows:

"SECTION 4. SEWER SERVICE CHARGE. A monthly sewer service charge for the use of the City's sewage disposal system is hereby established and the monthly rates therefore shall be as follows:

- (a) SINGLE FAMILY USERS: For the period commencing September 1, 1979 and ending August 31, 1980 the sum of Four Dollars (\$4.00). For the period commencing September 1, 1980 and continuing thereafter until this Ordinance is repealed or amended the sum of Two Dollars (\$2.00).
- (b) MULTIPLE FAMILY USERS: For the period commencing September 1, 1979 and ending August 31, 1980, the sum of Four Dollars (\$4.00) for the first dwelling unit plus the further sum of Two Dollars (\$2.00) for each additional dwelling unit located within the structure or complex when the same are served by a common service line connecting with the City's lateral or main. For the period commencing September 1, 1980 and continuing thereafter until this Ordinance is repealed or amended the sum of Two Dollars (\$2.00) for the first dwelling unit plus the further sum of One Dollar (\$1.00) for each additional dwelling unit located within the structure or complex when the same are served by a common service line connecting with the City's lateral or main.
- (c) BUSINESS USERS: For the period commencing September 1, 1979 and ending August 31, 1980 the sum of Eight Dollars (\$8.00). For the period commencing September 1, 1980 and continuing thereafter until this ordinance

is repealed or amended the sum of Four Dollars (\$4.00).

- (d) SCHOOL USERS: For the period commencing September 1, 1979 and ending August 31, 1980 the sum of Fifty Dollars (\$50.00). For the period commencing September 1, 1980 and continuing thereafter until this ordinance is repealed or amended the sum of Twenty-five Dollars (\$25.00).
- (e) SKILLED NURSING HOME USERS: For the period commencing September 1, 1979 and ending August 31, 1980 the sum of Fifty Dollars (\$50.00). For the period commencing September 1, 1980 and continuing thereafter until this ordinance is repealed or amended the sum of Twenty-five Dollars (\$25.00).
- (f) OTHER USERS: For the period commencing September 1, 1979 and ending August 31, 1980 the sum of Four Dollars (\$4.00). For the period commencing September 1, 1980 and continuing thereafter until this Ordinance is repealed or amended the sum of Two Dollars (\$2.00).

Usage of the sewage disposal system by any sewer user for part of any month shall be considered and charged as usage for the full month."

SECTION 2. The rates established by this Ordinance shall be effective for all sanitary sewer services furnished by the City to its customers and users from and after September 1, 1979 and from and after the passage of this Ordinance and its publication in the official City paper, whichever date shall be the later.


SECTION 3. Section 4 of Ordinance No. 313 of the City of Wathena is hereby repealed.
