

ORDINANCE NO. 417

AN ORDINANCE RELATING TO AN INTERLOCAL COOPERATION AGREEMENT CREATING THE DONIPHAN COUNTY ECONOMIC DEVELOPMENT COMMISSION, PRESCRIBING CERTAIN TERMS FOR SUCH AGREEMENT, AND AUTHORIZING THE CITY OF WATHENA TO ENTER INTO SUCH AGREEMENT.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WATHENA, KANSAS:

SECTION 1. INTERLOCAL COOPERATION AGREEMENT AUTHORIZED. (a) Pursuant to the provisions of this ordinance and Kansas Statutes Annotated, Chapter 12, Article 29, as amended, the City of Wathena, Kansas, (hereinafter referred to as "City") shall be and it is hereby authorized and empowered to enter to a certain Interlocal Cooperation Agreement with the Cities of Elwood, Troy and Highland, Kansas, the County of Doniphan, Kansas, and the Doniphan County Chamber of Commerce creating and relating to the Doniphan County Economic Development Commission.


(b) Such agreement shall be executed and attested by and on behalf of the City by the Mayor and the City Clerk of the City.

SECTION 2. PROVISIONS OF AGREEMENT. Such agreement shall: (a) Create a joint administrative entity to be known as The Doniphan County Economic Development Commission, (b) define the powers of such Commission (c) prescribe a method for the exercise of the powers of the Commission, (d) provide for the funding of the operation of the Commission with financial participation by the City to be at the City's option, (e) provide for the allowance and payment of obligations of the Commission, (f) provide for the acquisition, use and disposition of property by the Commission and for the staffing of the Commission, and (g) provide for the final termination of such agreement on January 1, 1998, subject, however, to the unilateral right of any party thereto to withdraw therefrom at the end of any calendar year prior to date of final termination. A true and correct copy of the agreement herein authorized is on file as a part of the public records in the office of City Clerk of the City.

SECTION 3. COPY OF AGREEMENT MAINTAINED IN CITY RECORDS. Upon and after the due and legal execution thereof by all of the parties thereto and upon the approval thereof by the Kansas Attorney General as required by law, an executed copy of such agreement shall be filed, kept and maintained with the

records in the office of the City Clerk of the City and shall be available for public inspection at all reasonable times.
