

## ORDINANCE NO. 448

AN ORDINANCE CLASSIFYING WATER CUSTOMERS OF THE CITY OF WATHENA, DEFINING SUCH CLASSES, ESTABLISHING RATES AND SALES PRICES FOR WATER SOLD AND DELIVERED BY THE CITY OF WATHENA TO CUSTOMERS OF SUCH CITY AND REPEALING ORDINANCE NO. 359 OF THE CITY OF WATHENA AND ALL OTHER ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WATHENA, KANSAS:

SECTION 1. DEFINITIONS. As used in this Ordinances:

- (a) "Residential Customer" means a single family private dwelling unit supplied through one meter for domestic use.
- (b) "Commercial Customer" means all other electric energy customers of the City not included within the definition of "Residential Customer" as set forth above.

SECTION 2. RATES FOR RESIDENTIAL CUSTOMERS WITHIN THE CITY. The following monthly rates and charges are hereby established for water delivered by the City of Wathena to residential customers located within the corporate limits of such City:

- (a) A minimum monthly charge of Seven and 83/100 Dollars (\$7.83) per month, which minimum charge shall include and pay for the first 2,000 gallons of water delivered to any one customer in any one month.
- (b) For the next 8,000 gallons the sum of Two and 09/100 Dollars (\$2.09) for each 1,000 gallons of water, or fraction thereof.
- (c) For each 1,000 gallons, or fraction thereof, in excess of 10,000 gallons the sum of One and 67/100 Dollars (\$1.67).

SECTION 3. RATES FOR COMMERCIAL CUSTOMERS WITHIN THE CITY. The following monthly rates and charges are hereby

established for water delivered by the City of Wathena to commercial customers located within the corporate limits of such City:

- (a) A minimum monthly charge of Eight and 99/100 Dollars (\$8.99) per month, which minimum charge shall include and pay for the first 2,000 gallons of water delivered to any one customer in any one month.
- (b) For the next 8,000 gallons the sum of Two and 15/100 Dollars (\$2.15) for each 1,000 gallons of water, or fraction thereof.
- (c) For each 1,000 gallons, or fraction thereof, in excess of 10,000 gallons the sum of One and 73/100 Dollars (\$1.73).

SECTION 4. RATES FOR RESIDENTIAL CUSTOMERS NOT WITHIN THE CITY. The following monthly rates and charges are hereby established for water delivered by the City of Wathena to residential customers located outside the corporate limits of such City:

- (a) A minimum monthly charge of Nine and 86/100 Dollars (\$9.86) per month, which minimum charge shall include and pay for the first 2,000 gallons of water delivered to any one customer in any one month.
- (b) For the next 8,000 gallons the sum of Two and 09/100 Dollars (\$2.09) for each 1,000 gallons of water, or fraction thereof.
- (c) For each 1,000 gallons, or fraction thereof, in excess of 10,000 gallons the sum of One and 74/100 Dollars (\$1.74).

SECTION 5. RATES FOR COMMERCIAL CUSTOMERS NOT WITHIN THE CITY. The following monthly rates and charges are hereby established for water delivered by the City of Wathena to commercial customers located outside the corporate limits of such City:

- (a) A minimum monthly charge of Fourteen and 25/100 Dollars (\$14.25) per month, which minimum charge shall include and pay for the first 2,000 gallons of water delivered to any one customer in any one month.
- (b) For the next 8,000 gallons the sum of Two and 78/100 Dollars (\$2.78) for each 1,000 gallons of water, or fraction thereof.
- (c) For each 1,000 gallons, or fraction thereof, in excess of 10,000 gallons the sum of Two and 33/100 Dollars (\$2.33).

SECTION 6. WATER DELIVERED AT STAND PIPE. All water sold by the City in tank lots and delivered at the City stand pipe shall be sold at the rate of Five and No/100 Dollars (\$5.80) per 1,000 gallons sold and delivered with a minimum charge of Twentynine Cents (\$.29) for any single tank lot delivery.

SECTION 7. EFFECTIVE DATE. The rates established by this Ordinance shall be effective for all water sold, delivered and billed for by the City pursuant to all of the foregoing sections from and after its passage and publication in the official City paper.

SECTION 8. REPEALER. Ordinance No. 359 of the City of Wathena and all other ordinances and parts of ordinances in conflict herewith are hereby repealed.

## ORDINANCE NO. 448

- (c) For each 1,000 gallons, or fraction thereof, in excess of 10,000 gallons the sum of One and 67/100 Dollars (\$1.67).

SECTION 3. RATES FOR COMMERCIAL CUSTOMERS WITHIN THE CITY. The following monthly rates and charges are hereby

established for water delivered by the City of Wathena to commercial customers located within the corporate limits of such City:

- (a) A minimum monthly charge of Eight and 99/100 Dollars (\$8.99) per month, which minimum charge shall include and pay for the first 2,000 gallons of water delivered to any one customer in any one month.
- (b) For the next 8,000 gallons the sum of Two and 15/100 Dollars (\$2.15) for each 1,000 gallons of water, or fraction thereof.
- (c) For each 1,000 gallons, or fraction thereof, in excess of 10,000 gallons the sum of One and 73/100 Dollars (\$1.73).

SECTION 4. RATES FOR RESIDENTIAL CUSTOMERS NOT WITHIN THE CITY. The following monthly rates and charges are hereby established for water delivered by the City of Wathena to residential customers located outside the corporate limits of such City:

- (a) A minimum monthly charge of Nine and 86/100 Dollars (\$9.86) per month, which minimum charge shall include and pay for the first 2,000 gallons of water delivered to any one customer in any one month.
- (b) For the next 8,000 gallons the sum of Two and 09/100 Dollars (\$2.09) for each 1,000 gallons of water, or fraction thereof.
- (c) For each 1,000 gallons, or fraction thereof, in excess of 10,000 gallons the sum of One and 74/100 Dollars (\$1.74).

SECTION 5. RATES FOR COMMERCIAL CUSTOMERS NOT WITHIN THE CITY. The following monthly rates and charges are hereby established for water delivered by the City of Wathena to commercial customers located outside the corporate limits of such City:

- (a) A minimum monthly charge of Fourteen and 25/100 Dollars (\$14.25) per month, which minimum charge shall include and pay for the first 2,000 gallons of water delivered to any one customer in any one month.
- (b) For the next 8,000 gallons the sum of Two and 78/100 Dollars (\$2.78) for each 1,000 gallons of water, or fraction thereof.
- (c) For each 1,000 gallons, or fraction thereof, in excess of 10,000 gallons the sum of Two and 33/100 Dollars (\$2.33).

SECTION 6. WATER DELIVERED AT STAND PIPE. All water sold by the City in tank lots and delivered at the City stand pipe shall be sold at the rate of Five and 80/100 Dollars (\$5.80) per 1,000 gallons sold and delivered with a minimum charge of Twenty-five Cents (\$.25) for any single tank lot delivery.

SECTION 7. EFFECTIVE DATE. The rates established by this Ordinance shall be effective for all water sold, delivered and billed for by the City pursuant to all of the foregoing sections from and after its passage and publication in the official City paper.

SECTION 8. REPEALER. Ordinance No. 359 of the City of Wathena and all other ordinances and parts of ordinances in conflict herewith are hereby repealed.
