## ORDINANCE NO. 459

AN ORDINANCE CHANGING THE ZONING CLASSIFICATION OF CERTAIN LANDS IN THE CITY OF WATHENA, KANSAS; AMENDING SECTION IV OF ORDINANCE NO. 244 OF SAID CITY OF WATHENA; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES OF THE CITY IN CONFLICT HEREWITH.

WHEREAS, The Doniphan County Regional Planning Commission, after notice duly published on September 24, 1992, and hearings held on October 14 and November 11, 1992, and January 13, 1993, has recommended the zoning changes hereinafter provided:

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WATHENA:

SECTION 1. ZONING CLASSIFICATION CHANGE. (a) The zoning classification for the following described real estate situate within the corporate limits of the City of Wathena, Doniphan County, Kansas, to wit:

Beginning 1,414.5 feet West of the Northeast corner of the Southwest Quarter of Section 27, Township 3, Range 22, thence West on the North line of said Southwest Quarter to the East right of way of the existing County Road, thence South along such right of way line to the center line of Old U.S. Highway 36, thence Easterly along the center line of Old U.S. Highway 36 to a point due South of the point of beginning, thence North to the point of beginning,

be and the same is hereby changed from A-1 AGRICULTURAL DISTRICT to R-3 MULTI-FAMILY RESIDENTIAL DISTRICT.

(b) The boundaries of Zoning District R-3 in said City of Wathena be and the same are hereby altered and changed to include the land described in Section 1 above and the boundary lines of Zoning District A-1 be and the same are hereby altered and changed to exclude the lands described in Section 1 above.

SECTION 2. ZONING CLARIFICATION CHANGE. (a) The zoning classification for the following described real estate situate within the corporate limits of the City of Wathena, Doniphan County, Kansas, to wit:

Beginning at the Northeast corner of the Southwest Quarter of Section 27, Township 3, Range 22, thence West on the North line of said Quarter Section 1,414.5 feet, thence South to the center line of Old U.S. Highway 36,

thence Easterly along said center line to a point due South of the point of beginning, thence North to the point of beginning, except tract owned by Oscar Pohl and Lydia M. Pohl recorded in Book 179 at Page 493 in the records in the office of the Register of Deeds of Doniphan County Kansas,

be and the same is hereby changed from A-1 AGRICULTURAL DISTRICT to R-1 SINGLE-FAMILY RESIDENTIAL DISTRICT.

(b) The boundaries of Zoning District R-1 in said City of Wathena be and the same are hereby altered and changed to include the land described in Section 2 above and the boundary lines of Zoning District A-1 be and the same are hereby altered and changed to exclude the lands described in Section 2 above.

SECTION 3. ZONING CLASSIFICATION CHANGE. (a) The zoning classification for the following described real estate situate within the corporate limits of the City of Wathena, Doniphan County, Kansas, to wit:

Beginning at the Southwest corner of Section 27, Township 3, Range 22, thence North 1403 feet more or less to the intersection of an extension East of the center line of Court Street in the City of Wathena, thence East 660 feet, thence South 1,403 feet more or less to the South line of said Section 27, thence West 660 feet more or less to the point of beginning, all being situate in the City of Wathena, Doniphan County, Kansas, and excepting therefrom a tract of real estate owned by Edwin D. Ford and Carolyn K. Ford as described in a certain deed dated November 2, 1987, and recorded in Book 179 at Page 422 of the records in the office of the Register of Deeds of Doniphan County, Kansas,

be and the same is hereby changed from I-2 LIGHT INDUSTRIAL DISTRICT to B-2 CENTRAL BUSINESS DISTRICT.

(b) The boundaries of Zoning District B-2 in said City of Wathena be and the same are hereby altered and changed to include the land described in Section 3 above and the boundary lines of Zoning District I-2 be and the same are hereby altered and changed to exclude the lands described in Section 3 above.

(b) The boundaries of Zoning District R-1 in said City of Wathena be and the same are hereby altered and changed to include the land described in Section 4 above and the boundary lines of Zoning District I-2 be and the same are hereby altered and changed to exclude the lands described in Section 4 above.

SECTION 5. ZONING CLASSIFICATION CHANGE. (a) The zoning classification for the following described real estate situate within the corporate limits of the City of Wathena, Doniphan County, Kansas, to wit:

- (b) The boundaries of Zoning District B-2 in said City of Wathena be and the same are hereby altered and changed to include the land described in Section 5 above and the boundary lines of Zoning District I-1 be and the same are hereby altered and changed to exclude the lands described in Section 5 above.
- SECTION 6. ZONING CLASSIFICATION CHANGE. (a) The zoning classification for the following described real estate situate within the corporate limits of the City of Wathena, Doniphan County, Kansas, to wit:

Beginning at a point on the North line of the Northwest Quarter of Section 28, Township 3, Range 22, which point is 1,170 feet more or less West of the Northwest corner of said Northwest Quarter such point also being the

intersection of such line with the Westerly right-of-way line of U.S. Highway 36, thence Northwesterly along the Westerly right-of-way line of said highway to a point which is 100 rods North of the South line of the Southwest Quarter of Section 21, Township 3, Range 22, thence East on a straight line to a point on the East line of the Southeast Quarter of Section 21 which is 100 rods North of the Southeast corner of the Southeast Quarter of Section 21, thence South on the East line of the Southeast Quarter of Section 21 to the Southeast corner of the Southeast Quarter of Section 21, thence East on the North line of the Northwest Quarter of Section 27, Township 3, Range 22, 524 feet East, thence South 560 feet more or less to the extension East of the North right of way line of Sherman Street, thence West along the North right of way line of Sherman Street to the East right of way line of Bellmont Road, thence South along the East right of way line of Bellmont Road to the West right-of-way of U.S. Highway 36, Northwesterly along the Westerly right-of-way U.S. Highway 36 to the point of beginning, excepting the following described tracts:

(b) The boundaries of Zoning District R-1 in said City of Wathena be and the same are hereby altered and changed to include the land described in Section 6 above and the boundary lines of Zoning District A-1 be and the same are hereby altered and changed to exclude the lands described in Section 6 above.

SECTION 7. ORDINANCE NO. 244 AMENDED. (a) Section IV C.2. is hereby amended to include all uses permitted in any B-1 NEIGHBORHOOD BUSINESS DISTRICT.

(b) Subsection C.2.b.(1) of Section IV of Ordnance No. 244 is hereby amended to include the following sentence:

"All uses permitted in any B-1 NEIGHBORHOOD BUSINESS DISTRICT."

SECTION 8. DIRECTIVE TO CITY CLERK. The City Clerk of the City of Wathena, Kansas, be and she is hereby ordered and directed to make the necessary changes on the official Zoning Map of the City of Wathena to reflect the Zoning Amendments and changes provided for herein and to make the necessary changes in the official city copy of Ordinance No. 244 to reflect the amendment provided for herein.
