ORDINANCE NO. 498

AN ORDINANCE AMENDING SECTION 2 OF ORDINANCE NO. 375 OF THE CITY OF WATHENA, KANSAS, RELATING TO RESIDENTIAL ELECTRIC ENERGY CUSTOMERS; AND REPEALING THE ORIGINAL SECTION 2 OF ORDINANCE NO. 375 AND ALL OTHER ORDINANCES AND PARTS OF ORDINANCES OF THE CITY OF WATHENA IN CONFLICT HEREWITH.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WATHENA, KANSAS:

SECTION 1. SECTION 2 OF ORDINANCE NO. 375 AMENDED. Section 2 of Ordinance No. 375 of the City of Wathena is hereby amended to read as follows:

"SECTION 2. RATES AND CHARGES FOR RESIDENTIAL CUSTOMERS.

(a) The following monthly rates and charges are hereby established for electric energy sold by the City of Wathena to Residential Customers served by the City which customers do not have total electric homes:

- (i) A minimum monthly charge of \$3.00 per month which minimum charge shall be assessed whether or not the customer consumes any electric energy.
- (ii) For the first Three Hundred Fifty (350) K.W.H. the sum of Ten Cents (\$.10) per K.W.H.
- (iii) For the next Two Hundred Fifty Cents (250) K.W.H. the sum of Nine Cents (\$.09) per K.W.H.
 - (iv) For the next Four Hundred (400) K.W. H. the sum of Eight Cents (\$.08) per K.W.H.
 - (v) For the next Five Hundred (500) K.W.H. the sum of Seven Cents (\$.07) per K.W.H.
 - (vi) For each K.W.H. in excess of One Thousand Five Hundred (1,500) K.W.H. the sum of Six Cents (\$.06)
- (b) The following monthly rates and charges are hereby established for electric energy sold by the City of Wathena to Residential Customers served by the City which customers have total electric homes:
 - (i) A minimum monthly charge of \$3.00 per month which minimum charge shall be assessed whether or not the customer consumes any electric energy.

- (ii) For the first Three Hundred Fifty (350) K.W.H. the sum of Nine Cents (\$.09) per K.W.H.
- (iii) For the next Two Hundred Fifty Cents (250) K.W.H. the sum of Eight Cents (\$.08) per K.W.H.
 - (iv) For the next Nine Hundred (900) K.W. H. the sum of Seven Cents (\$.07) per K.W.H.
 - (v) For each K.W.H. in excess of One Thousand Five Hundred (1,500) K.W.H. the sum of Six Cents (\$.06)
- (c) In addition to the foregoing charges for total K.W.H. consumed by each Residential Customer during any monthly period, such Residential Customer shall be billed for and shall pay the monthly Fuel Adjustment Charge provided for in Section Four below and for the Summer Highest Capacity Charge for large users provided for in Section Five below."

SECTION 2. REPEALER. The original Section 2 of Ordinance No. 375 and all other ordinances and parts of ordinances of the City of Wathena, Kansas, in conflict herewith are hereby repealed.

SECTION 3. EFFECTIVE DATE. This Ordinance shall take effect and be in force from and after its publication in The Wathena Times, the Official City Newspaper.
