

Ordinance No. 80

An Ordinance Providing for the Grading, Curbing, Guttering, Draining, Paving and Otherwise improving the following named street in the City Of Wathena, Doniphan County Kansas: Part of Doniphan Street.

Designating the width of Roadway, Providing for the Preparation of Plans and Specifications, Estimating the Costs of said Improvements and the Letting of Contracts Therefor.

Whereas, more than three-fourths of the resident property owners fronting on the following named street in the City of Wathena, Koniphan County Kansas, to-wit: Doniphan street that lies between adjacent block 13 and 14, 7 and 8, and 3 and 4 in original town of Wathena and between blocks 3 and 4 in North Wathena, an addition to original City of Wathena, from north line St. Joseph Street north to north line Freemont Street have prepared, signed and filed with the Council of said city their petition asking the Mayor and Council of said city to grade, curb, gutter, drain, pave and otherwise improve said street within the boundaries as last above described, and

Whereas, The Mayor and Council have been informed and find that said petition is signed by more than three-fourths of the resident property owners fronting on said street or owning property in the blocks fronting on said streets to the depth of half said blocks from said street and that the signatures to said petition are the genuine signatures of said resident owners.

Therefore, Be it Ordained by the Mayor and Councilmen of the City of Wathena, Doniphan County, Kansas be and they are hereby authorized, empowered and ordered to cause that part of the following named street in the city of Wathena, Doniphan County, Kansas, to-wit: Doniphan street that lies between adjacent blocks 13 and 14, 7 and 8, and 3 and 4 in original town of Wathena and between blocks 3 and 4 in North Wathena, an addition to original City of Wathena, from north line St. Joseph street north to north line Freemont street to be graded, curbed, gruttered, drained, paved and otherwise improved to a width between faces of curbs, with such material and according to the plans and specifications of the city engineer of the city of Wathena, Kansas as are hereinafter provided.

Said street shall be so improved in width as follows:

Forty feet between face of curbs over all but except the center eighteen feet to be occupied by Pikes Peak Highway, Federal Aid Road District Number 5, Federal Aid Project Number 53, between blocks 13 and 14, thence north between blocks 7 and 8 and 3 and 4 in original town of Wathena and between blocks 3 and 4 in North Wathena, the width of thirty feet between face of curbs over all but except the center eighteen feet to be occupied by said Pikes Peak Highway, Federal Aid Road District Number 5, Federal Aid Project Number 53.

Sec. 2 For the work and improvements herein provided for the city engineer of the city of Wathena, Kansas shall make and file with the City Clerk of said city on or before the 1st day of December 1920, complete plans: profiles, specifications and estimates of cost for the work and improvements in said street as follows: Of the same construction and material as is provided for in the Pikes Peak Highway, Federal Aid Road District Number Five (5) and Federal Aid Project Number Fifty-three (53).

Sec. 3. That after said plans and specifications shall have been prepared and filed with the city Clerk as provided for herein, the Mayor and Council shall advertise for and receive bids for the excavating, grading and draining of the part of said street to be improved and to advertise for and receive bids for the curbing, guttering, paving and otherwise improving that part of said street to be improved, and the said Mayor and Council are hereby authorized to accept or reject said bids and to let the contract or contracts for said improvements as herein provided to such bidders as said Mayor and Council may accept, reserving the right to reject and or all bids as they see fit.

Sec. 4. This ordinance shall take effect and be in full force and effect from and after its publication once in the Wathena Times.
