## Ordinance No. 92

An Ordinance providing for the issuing of Paving Bonds of the City of Wathena, Doniphan County, Kansas for paying for the paving additional to the eithteen feet of highway.

Whereas, the cost of grading, curbing, guttering and paving of St. Joseph street from Moss street to 100 feet west of the west line of Doniphan street, and of Doniphan street from St. Joseph street to Freemont street and of Freemont street from Doniphan street to Arch street and of the intersections of streets and alleys on said streets, outside of the eighteen feet of hard surfaced paving being placed in connection with the Piked Peak Ocean to Ocean Highway Federal Aid Project Number 53, has been ascertained and is determined to be the sum of \$33,628.78 and of this amount the sum of \$21,935.97 has been assessed against abutting property to said payment, but for the payment of which sum the city obligates itself, and the sum of \$11,692.81 has been determined to be the share of said City of Wathena, as a whole for the cost of grading for the cost of intersections of streets and alleys and it has been determined necessary to pay all said cost by annual installments running through a period of fifteen years, and that improvement bonds shall be issued and sold to pay for the cost of said improvements, except for the sum of \$6,344.50 paid in full by property owners on their assessments and except for the sum of \$2,284.28 now in the city treasury and available for payment on the cost of said improvements.

Now, Therefore, Be it Ordained by the Mayor and Councilmen of the City of Wathena, Doniphan County, Kansas.

Sec. 1. That the cost of grading, curbing, guttering and paving St. Joseph street from the east side of Moss street to the east end of the concrete bridge over Peter's creek, being 100 feet west of the west side of Doniphan street and of grading, curbing, gutterin and paving Doniphan Street from the north side of St. Joseph street to the north side of Freemont Street and of grading, curbing, guttering and paving Freemont street from the west side of Doniphan street to the east line of Arch street, all in Wathena Donipahan County, Kansas, but excepting therefrom a strip through the center of each of said streets eighteen feet wide to be paved as a part of Federal Aid Project Number 53, and after applying on said costs the payments made by the property owners and the sum of money above set out as in the city treasury subject to use on the cost of said improvement, shall be paid by the issuance and sale of improvement bonds in the sum of \$25,000.00 by the City of Wathena. That said bonds shall be dated the first day of April 1922, shall bear five\_percent\_interest\_per\_annum\_payable\_semiannually\_on-the-first-daysof January and July of each year at the Fiscal Agency of the State of Kansas at Topeka, Kansas, and evidenced by interest coupons attached to said bonds. That said bonds shall be numbered and shall mature in amounts and dates as follows:

Said bond shall be signed by the Mayor and attested by the City Clerk and have impressed thereon the corporate seal of the city of Wathena and said coupons shall be authenticated by the lithographed or actual signatures of said Mayor and City Clerk. Said bonds shall not be sold for less than par value and shall be payable serially as above provided at the Fiscal Agency of the State of Kansas and said Mayor and Clerk are hereby authorized to execute said bonds and coupons as are provided for in this ordinance and deliver the same to The Fidelity National Bank and Trust Company of Kansas City, Missouri, the purchaser under the contract heretofore entered into on the payment of the purchase price according to the terms of said contract, and for the payment of said bonds and interest thereon annual levies shall be made as provided by law on all property liable therefor.

Section 2.—Said-bonds-shall-be in-substantially-the-following-form and with recitals as follows:

KNOW ALL MEN BY THESE PRESENTS: That the City of Wathena in the County of Doniphan, State of Kansas, for value received, hereby acknowledges itself to be indebted and promisesto pay to the bearer the sum of .....dollars in lawful money of the United States of America, on the first day of July 19... with interest thereon at the rate of Five percent (5%) per annum, payable semi-annually on the 1st day of January and July of each Year after the date hereof until the principal sum shall have been paid, upon the presentation and surrender of the proper interest coupons hereto attached, bearing the facsimile signatures of the Mayor and the Clerk of said City, as they severally become due; both principal and i interest are payable at the Fiscal Agency of the State of Kansas, in the City of Topeka, Kansas; and the City of Wathena is held and firmly bound, and its faith and credit and all real and personal property in said City are hereby pledged for the prompt payment of the principal of this bond and the interest thereon at maturity.

THIS BOND is one of a series of thirty-five bonds of like date, tenor and effect, except denomination and maturity, numbered from one to thirtyfive inclusive, aggregating \$25,000.00 issued by the City of Wathena to pay for street improvements in and for said City under and by authority of and in compliance with the provisions of the laws of the State of Kansas governing cities of the third class, and in compliance with ordinances duly and legally passed by the Mayor and Councilmen of said city.

AND IT IS FURTHER DECLARED AND CERTIFIED that all acts, conditions and things required to be done and to exist precedent to the issuance of this bond have been properly done and performed and do exist in regular, and due form as required by the Constitution and laws of the State of Kansas and that the total indebtedness of said City, including this series of bonds, does not exceed any constitutional or statutory limitation.

IN WITNESS WHEREOF, said City of Wathena, Kansas, by its Mayor and Councilmen has caused this bond to be signed by its Mayor and attested by its Clerk and its corporate seal to be hereto affixed and this bond to be dated the first day of April, 1922.
