A RESOLUTION RELATING TO THE CONSTRUCTION OF SEWER LATERALS IN EVERGREEN, CRESCENT AND ALLENDALE STREETS IN SEWER DISTRICT NO. 1 - EAST WATHENA.

WHEREAS, the City of Wathena, Kansas, by Resolution No. 74-2 of the City of Wathena created a special improvement district to provide for the construction of certain sanitary sewer improvements, which such district was designated as "Sewer District No. 1 - East Wathena"; and,

WHEREAS, the parties to said suit, Coursen Construction Co., Inc., as Plaintiff and the City of Wathena, Kansas, as Defendant, are desirous of disposing of said suit without further litigation and have stipulated and agreed to dismiss said suit upon the passage of this Resolution by the Governing Body of the City of Wathena, Kansas:

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF WATHENA:

- 1. When and as sewer laterals are hereafter constructed in Evergreen, Crescent and Allendale Streets in Schuster's Pine Cone Villa Addition to the City of Wathena, Kansas, the owner of the lots adjoining said streets, Coursen Construction Co., Inc., or its successor in title, shall have the right to lay and construct the laterals in said streets at the expense of Coursen Construction Co., Inc. or its successor in title, subject to supervision by the City of Wathena and according to standards and specifications imposed by the City of Wathena.
