Å RESOLUTION APPROVING THE ISSUANCE BY THE CITY OF WATHENA, KANSAS OF ITS INDUSTRIAL REVENUE BONDS IN THE AGGREGATE PRINCIPAL AMOUNT OF \$4,000,000 TO PAY THE COSTS OF ACQUIRING, CONSTRUCTING AND EQUIPPING A MANUFACTURING FACILITY TO BE LEASED TO SKYJACK, EQUIPMENT, INC. WHICH FACILITY IS LOCATED IN UNINCORPORATED TERRITORY IN DONIPHAN COUNTY, KANSAS OUTSIDE THE CORPORATE LIMITS OF THE CITY OF WATHENA, BUT WITHIN THREE MILES THEREOF.

WHEREAS, on December 16, 1997, the governing body of the City of Wathena, Kansas he "City") passed its Resolution No. 97-6 authorizing the issuance of certain industrial revenue inds in an aggregate principal amount of not to exceed \$6,000,000, as more particularly set in said Resolution; and

WHEREAS, the proceeds of \$4,000,000 principal amount of such bonds (the "Bonds") ill be used to pay the costs of acquiring, constructing and equipping a manufacturing facility he "Project") located in unincorporated territory in Doniphan County, Kansas, outside the provide the importance limits of the City of Wathena, but within three miles thereof;

WHEREAS, notice of the City's intention to issue the Bonds was given to the Board insuant to K.S.A. 12-1741a, and a public hearing was held before the Board immediately ecceding the adoption of this Resolution pursuant to notice published at least 14 days prior to e date of the hearing in a newspaper of general circulation in the County, proof of which is tached to this Resolution as *Exhibit A*; and

WHEREAS, the Board has found and determined that the acquisition, construction and juipping of the Project and issuance of the Bonds would serve the public purposes stated in the ansas Economic Development Revenue Bond Act, as amended and codified in K.S.A. 12-1740 *seq.*(the "Act"); and

WHEREAS, the Board has found and determined that issuance of the Bonds will not eate, and is not intended to create any financial liability upon the Bonds on the part of the ounty;
