## RESOLUTION NO. 01-1

## A RESOLUTION DECLARING THE CORPORATE BOUNDARIES OF THE CITY OF WATHENA, DONIPHAN COUNTY, KANSAS,

WHEREAS, the Governing Body of the City of Wathena, Kansas, has added territory to its corporate boundaries during the year 2000; and,

WHEREAS, K.S.A. 12-517 requires a declaration, by the Governing Body of said City of the entire boundaries of said City:

NOW, THEREFORE, BE IT RESOLVED AND DECLARED BY THE GOVERNING BODY OF THE CITY OF WATHENA, DONIPHAN COUNTY, KANSAS:

1. The following is a complete metes and bounds description of the present corporate limits of the City of Wathena, Doniphan County, Kansas, to wit:

Beginning at the Southeast Corner of the Southeast One-Quarter (SE 1/4) of Section 28 Township 3 South, Range 22 East of the Sixth Principal Meridian, Doniphan County, Kansas; thence S 89 degrees $37^{\prime} 46^{\prime \prime}$ W (assumed bearing), 2,666.14 feet to the Southwest corner of said SE $1 / 4$; thence continuing West on the South line of Section 28 to a point which is 1,170 feet West of the Southeast corner of the Southwest Quarter of Section 28 (such point being also the Southwest corner of Outlot V in Constantinople or Western Addition to Wathena); thence North on a straight line to a point on the North line of the Northwest Quarter of Section 28 which point is 1,170 feet West of the Northeast Corner of the Northwest Quarter of Section 28 (such point beginning also on and at the Westerly right-of-way line of U.S. Highway No. 36); thence North and Northwesterly along the Westerly right-of-way line of U.S. Highway No. 36 to a point on said Westerly right-of-way line which is 100 rods North of the South line of the Southwest Quarter of Section 21; thence East on a straight line to a point on the East line of the Southeast Quarter of Section 21 which is 100 rods North of the Southeast corner of the Southeast Quarter of Section 21; thence South on the East line of the Southeast Quarter of Section 21 to the Southeast corner of the Southeast Quarter of Section 21; thence East on the North line of the Northwest Quarter of Section 27 to a point 524 feet East of the Northwest corner of the Northwest Quarter of Section 27; thence South on a straight line to a point on the North line of the Southwest Quarter of Section 27 which is 524 feet East of the Northwest corner of the Southwest Quarter of Section 27; thence East on the North line of the Southwest Quarter of Section 27 to the Northeast Corner of the Southwest Quarter of Section 27; thence N 89 degrees 56'33" E (assumed bearing) 2,647.13 feet along the North line of said SE $1 / 4$ of Section 27 to the Northeast Corner of said SE $1 / 4$; thence S 0 degrees $34^{\prime} 26^{\prime \prime} \mathrm{E}, 850.47$ feet along the East line of said SE $1 / 4$ to a point on the South Right-of-Way (R/W) line of a County Road; thence following said County Road R/W, S 43 degrees 50'25" E, 29.18 feet;
