FINANCIAL REPORTS OF THE CITY OF WATHENA, KANSAS.



WHEREAS there are no revenue bond ordinances or other ordinances or resolutions of the City of Wathena which require financial statements and financial reports to be prepared in conformity with K.S.A.75-1120a(a) as they apply to the City of Wathena for the year 2015.


NOW, THEREFORE BE IT RESOLVED, by the governing body of the City of Wathena, Kansas, pursuant to the provisions of K.S.A. 78-1120a(c)(1) that the governing body request the Director of Accounts and Reports to waive the requirements of K.S.A.75-1120a(a) as they apply to the City of Wathena for the year 2015.

BE IT FURTHER RESOLVED that the governing body shall cause the financial statements and financial reports of the City of Wathena, Kansas to be prepared on the basis of cash receipts and disbursements as adjusted to show compliance with the cash basis and budget laws of the State of Kansas.
